Bid Opening: Designation of the official county newspaper for advertising of all legal notices and delinquent tax lists as well as all notices to be published by newspapers of general circulation in Klickitat County per the RCW.

- 1) Service Agreement between Klickitat County (Economic Development Department) and the Columbia Gorge Housing Authority for the purpose of providing funding not to exceed ten thousand dollars (\$10,000) for services as outlined in the Scope of Work from the U.S. Department of Housing and Urban Development to fund the Shelter Plus Care program for rental assistance payments made on behalf of Klickitat County participants, effective April 1, 2019, to March 2020.
- Resolution in the matter of Designation of County Crisis Responders to perform mental health investigations, initial detentions, and other duties and responsibilities in accordance with RCW 71.05 and other applicable RCW's and WAC's as they now exist or are modified in the future. - 3) Resolution in the matter of awarding 2020 Historic Preservation Grant Program funding in the amount of \$7,000 as follows:

- 4) Right-of-Way Easement for the purpose of granting an easement to Public Utility District No. 1 of Klickitat County and its successors and assigns, a perpetual easement over, under and across the property located at the Columbia Gorge Regional/The Dalles Municipal Airport for the purpose of extending power into individual lots.
- 5) Resolution in the matter of authorizing the issuance of a note in the principal amount not to exceed \$10,000,000 fixing the terms and covenants of the note and approving the sale and providing for the delivery of the note to Cashmere Valley Bank. The resolution will allow the County to process payments until the completion of the LOCAL Program, funds are available in June 2020.
- 6) Gorge Commuter Annual Pass Fare Program Contract between Mid-Columbia Economic Development District (MCEDD) and Klickitat County (Mt. Adams Transportation Service (MATS)) for the purpose of providing the employee pass to ride MATS fixed-route service. The contract will provide \$15,050 in revenue; the contract shall be in effect from January 1, 2020, to December 31, 2020.

- 7) Contract and Contract Bond between Klickitat County (Public Works Department) and Apply-A-Line, LLC. for the 2020 Annual Striping Program, RN 642-20 as bid in the amount of \$326,803.00 and authorization for the Public Works Director to execute any change orders for this project due to unforeseen conditions up to 10% of the contract (\$32,680.30).
- 8) Small Works Contract between Cole Industrial, Inc. and Klickitat County (Public Works Department) for the Klickitat County Courthouse Boiler Repair Project, as bid in the amount of \$11,825.00; and authorize the Public Works Director to execute any change orders for this project due to unforeseen conditions up to 10% of the contract (\$1,182.20 plus tax) for an aggregate of \$13,007.50.
