- 1) Klickitat County Small Business Emergency Grant Agreements between Klickitat County (Economic Development Department) and local businesses, to provide Coronavirus Aid, Relief, and Economic Security Act funding assistance through the Washington State Department of Commerce to ensure the public health and promote public welfare, including ameliorating the economic hardship caused by business closures associated with the COVID-19 pandemic. The intended outcome of this agreement is to support a business in Klickitat County impacted by the COVID-19 emergency in order to prevent the closure of the business.
- A purchase request from the Department of Emergency Management for a yearly subscription service that is web-based for the PowerDMS software for use in document management and training within the department. The cost is \$3,872.07 including tax.

- 3) Amendment No. 2 to Project Agreement #19-1656P Lead Entity Operating Grant between Klickitat County (Natural Resource Department) and the Washington State Recreation and Conservation Office for the purpose of increasing the funding level increase from \$50,959.00 to \$110,959.00. All other aspects of the Agreement to which this is an amendment shall remain in full force and effect.
- 4) A Resolution in the matter of revising the Public Health Department's Organizational Chart to include a Temporary Casual Public Health Nurse and a Temporary Casual Clerical Administrative Assistant I position to assist in COVID-19 response efforts. Temporary Casual Public Health Nurse, grade 70; Temporary Casual Clerical Administrative Assistant I, grade 34, effective January 15, 2020.
- 5) A resolution in the matter of hiring the retired Budget/Information Technology Director Glen Chipman as a Casual Fiscal Manager employee to assist the Human Resources/Administrative Services Director Robb Van Cleave with budget-related tasks and projects. Effective July 21, 2020, at the rate of \$51.95 per hour.
