- 2) Memorandum from the Planning Department scheduling a public hearing to be held Tuesday, September 24, 2019, at 1:30 pm to consider approval of a 4-lot Short Plat, SPL 2018-25. This is a short plat located in the Glenwood vicinity on Parcel 06-12-1300-0011/01; Applicants: Danielson/Kuhnhausen.
- 3) Interagency Agreement IAA20046 between Washington State Administrative Office of the Courts and Klickitat County (Juvenile Department) for the support of CASA programs to increase the number of children served by court-appointed special advocates (CASAs) in dependency matters or to reduce the average caseload of volunteers to recommended CASA standards. This contract is effective July 1, 2019, and shall remain in effect through June 30, 2020.
- 4) Interagency Agreement IAA20078 between Washington State Administrative Office of the Courts and Klickitat County Juvenile Court for Becca Programs and Services to engage the services of the Contractor to process Truancy At-Risk Youth and Child in Need of Services (BECCA) programs and services within its jurisdiction and according to the intent of the Becca legislation chapter 13.32, RCW. This contract is effective July 1, 2019, and shall remain in effect through June 30, 2020.
- 5) Resolution in the matter of setting a public hearing to consider amending Klickitat County Code Title 15, to move the fee schedule out of Title 15 to alleviate the public hearing process every year to adopt the fee increases.
- Resolution in the matter of setting a public hearing to consider amending Klickitat County Code Title 16, to move the fee schedule out of Title 16 to alleviate the public hearing process every year to adopt the fee increases.
