The County uses a combination of letters, flyers, and open house meetings to communicate with residents directly affected by projects. Public notices included a Title VI Non-Discrimination Statement.

Due to the Covid pandemic no open houses were held during this reporting period.

During this reporting period two environmental project reviews were completed for two federal aid projects. Those projects were: W. Darland Drive Overlay and Roosevelt Grade Road Overlay. A NEPA Categorical Exclusion Documentation Form was completed for both projects. Part 4, Section 13 addresses Environmental Justice. Both projects met exemptions for further analysis and study in this area.

The only transportation related public meeting during the reporting period was our 6-year Transportation Improvement program. Due to the Covid-19 pandemic during this reporting period, no in-person meetings were held. The County only received email comments and transportation staff were not able to determine the demographics of those who attended during the Zoom meeting.

All construction and consultant contracts are advertised in the county's newspaper of record and online Builders Exchange of Washington for at least the minimum advertisement period prescribed by law. Every solicitation includes a Title VI statement.

For construction projects, once the advertisement period has ended and bids have been received, they are publicly opened and the lowest responsive bidder is awarded the contract.

For consulting solicitations, once the advertisement period has ended and proposals have been received, the proposals are evaluated by a panel of public works employees and scores are tabulated. When necessary, interviews are held with prospective firms. When all evaluations have been completed the firm with the highest score of all evaluators is then contacted and negotiations on fees are initiated. Once fees have been agreed upon by both parties, the agreement is signed.

Solicitations for all Consultant and Construction contracts are advertised in the County newspaper of record. A Title VI Non-Discrimination statement was included in the advertisement for these projects.

Language from Appendix A in the Standard Title VI/Non-Discrimination Assurances are included in all transportation construction and consultant contracts. During the administration of transportation projects Klickitat County has a pre-construction meeting and discusses the EEO and Title VI requirements in our contracts.
