

STATE ENVIRONMENTAL POLICY ACT (SEPA)
ADDENDUM FOR
Klickitat River Watershed Management Plan

The following Addendum has been prepared pursuant to provisions of WAC 197-11-625.

Proposal: The *Klickitat River Watershed Management Plan*

Description of proposal: The *Klickitat River Watershed Management Plan* was developed in accordance with provisions of the state's Watershed Planning Act, Chapter 90.82 RCW. It was approved by consensus of members of the WRIA 30 Planning Unit appointed to represent units of government and by a majority vote of the nongovernmental members of that unit. The plan consists of recommendations to address: 1) current and future demands for water supply within the watershed; 2) surface and ground water quality problems; 3) limited stream flows in distinct stream reaches; 4) protection, restoration, and enhancement of fish habitat; and 5) effects of climate change.

Proponent: Klickitat County, the Lead Agency for the *Klickitat River Watershed Management Plan*.

Environmental document added to or modified by the addendum: The document for which additional information is being provided is the SEPA Determination of Significance and Adoption of the *Final Environmental Impact Statement for Watershed Planning under Chapter 90.82 RCW*. That State Environmental Policy Act document was prepared by the Washington State Department of Ecology and has been adopted by the co-lead agencies for the project, Klickitat County Planning Department and the Washington State Department of Ecology, in lieu of preparation of a SEPA Environmental Impact Statement per provisions of RCW 43.21C.150 and WAC 197-11-610.

Addendum: This addendum provides pertinent information that was not included in the SEPA Determination of Significance and Adoption of the *Final Environmental Impact Statement for Watershed Planning under Chapter 90.82 RCW*. The addendum consists of the attached document: *Evaluation of the Adequacy of the Final Environmental Impact Statement for Watershed Planning under Chapter 90.82 RCW (Ecology 2003) in Meeting SEPA Requirements Associated with Adoption of the WRIA 30 Management Plan*.


